

PRIVACY POLICY FOR GOTCHA!

Introduction

This is the Privacy Policy of Gotcha! (“me”, “I”, or “my”). In this Privacy Policy, I refer to my applications and services as the “Application.” Please read on to learn more about my data handling practices. Your use of the Application signifies that you agree with the terms of this Privacy Policy. If you do not agree with the terms of this Privacy Policy, do not use the Application.

Information I collect

When you install Application on your device I collect the following types of information from you:

First Name, Last Name, Email Address

Gotcha! may also collect and gather personally identifiable information, such as certain profile information including age, gender, preferences and publicly-available profiles on other applications (for example your name, email address, and profile pictures).

Gotcha! may collect and store information about your and others’ usage of and interaction with the other members, text messages, usage, statistics on page views.

Gotcha! may collect and gather user contents (e.g., photos, comments, and other materials) that you create on the Application.

By choosing to share that information, you should understand that you may no longer be able to control how that information is used and that it may become publicly available (depending in part on your actions or the actions of others with whom you have shared the information). I am not responsible for any use or misuse of information you share.

Currently, Gotcha! does not offer tools that allow you to opt-out of the collection of Personal Information.

Sharing of your information

I will not trade, rent or sell your information to third parties.

Any information or content that you voluntarily disclose for posting to Gotcha!, such as User Content, becomes available to the public. Once you have shared User Content or made it public, that User Content may be re-shared by others.

Your information may be stored and processed in any country in which Gotcha! maintains facilities. In this regard, or for purposes of sharing or disclosing data as described in this Privacy Policy, I reserve the right to transfer information outside of your country. By using the

Application, you consent to any such transfer of information outside of your country.

In addition, due to the inherent nature of the Internet and related technology, I do not guarantee the protection of information under my control against loss, misuse or alteration.

How I use information I collect

I use or may disclose your personal information only as follows:

- To connect you with others as enabled by Gotcha!;
- To share your Profile with others on Gotcha!;
- To show you the names of persons you communicate with and to show your name to persons you communicate with on Gotcha!;
- To deliver to you any administrative notices, alerts and communications relevant to your use of Gotcha!;
- To provide you with relevant content that you requested, using information that you allow me to collect from you or that you provide to a social media provider with which your Gotcha! account is connected, such as information regarding your and your Gotcha! contacts' respective locations;
- For internal operations, including troubleshooting problems, data analysis, testing, research, improvements to Gotcha!, detecting and protecting against error, fraud or other illegal activity;
- When I have a good faith belief that the law, any legal process, law enforcement, national security or issue of public importance requires disclosure;
- To protect and defend my rights or property;
- In connection with a corporate transaction involving Gotcha!, such as the purchase or sale of a business unit, an acquisition, merger, sale of assets, or other similar event.

Occasionally, at my discretion, I may include or offer third party products or services in Gotcha!. These third party services have separate and independent privacy policies. I therefore have no responsibility or liability for the content and activities of these linked applications. Nonetheless, I seek to protect the integrity of my applications and welcome any feedback about these applications.

I reserve the right at my discretion to make changes to this Privacy Policy. You may review updates to my Privacy Policy at any time via the Gotcha! website. I reserve the right to modify this policy from time to time, so please review it frequently.

If I make material changes to this policy, I will notify you by publishing a revised Privacy Policy or as required by law. You agree to review the Privacy Policy periodically so that you are aware of

any modifications. You agree that your continued use of the Application after I publish a revised Privacy Policy or provide a notice on my applications constitutes your acceptance of the revised Privacy Policy. If you do not agree with the terms of the Privacy Policy, you should not use Gotcha!.
